Optional School Vacation Package		
<p>NEW-you can choose to add on the school vacation package and your child will be automatically enrolled in the school vacation weeks in December, February and April for just \$65/month.</p>		

- ★ **NEW-No School Days now included with no extra fees** for attendance on early release days, snow days & delays (if we are open), public school professional development days and many school holidays. If school is closed on your regularly scheduled day your child is automatically eligible for care with us with no extra fees! School Vacation weeks and Summer Camp are NOT included in the regular monthly rates but can be added if needed.
- ★ You can sign up for any combination of days. However, schedules must be consistent from week-to-week except when signing up for extra days and the school vacation package.
- ★ Enrollment in the School Age Program follows the Charlton academic school calendar beginning when school starts in August and through the last day of school in mid/late June.
- ★ The School Age Program *monthly* rates are billed in 10 equal, monthly payments due on the first of every month from September 1st – June 1st.
- ★ The Children of Tomorrow Inc. is privately owned and operated. We are not a franchise and have been proudly providing top-notch childcare services to our community for 20 years! Our staff are educated and experienced teachers who strive to make a difference in the lives of their students.
- ★ School Age Summer Camp is a separate, optional program that is also available during summer break. Those of you who are enrolled in our School Age Program will get the opportunity to sign up for Summer Camp before we open enrollment to the public. Space is limited and this program fills up fast.

*The rates and dates are based on a traditional school year schedule and do not include a remote learning or hybrid learning model. Enrollment in this program does not include School Vacation Weeks (unless selecting the school vacation package) or Summer Camp and follows the COT Closing Calendar found on our website at www.thecotinc.com.

_____ I understand that a non-refundable deposit in the amount of one month's tuition is required to reserve a spot for my child and must be submitted with this completed contract. The full deposit amount will be held as a security deposit and applied toward the last month of service at the center. If the contract for care must be terminated due to failure to comply with center policies, I understand I will not be eligible for the return of the security deposit.

_____ I understand that the school age program start and end date is based on the first and last day of school according to the Dudley-Charlton School district calendar. The rates and dates are based on a traditional school year and do not include a remote or hybrid learning model.

_____ From time to time we send out important text messages regarding emergency closures or other time sensitive information. I understand cell numbers will be set to "opt in" for text messages.

_____ I understand the medical policy and that The Children of Tomorrow Early Learning Center must have an up-to-date copy of my child's required enrollment forms including medical and allergy forms.

***PLEASE TURN OVER AND INITIAL THE NEXT FEW STATEMENTS. ***

_____ I am aware that enrollment in the before and after school program NOW INCLUDES care for any "out of school time" such as public-school professional development days, early releases, many holidays, snow days, and 2- hr. delays that may fall on a day of the week my child is enrolled in the program.

_____ I understand that Drop-in-Care, Extra Days, School Vacation Weeks (unless I've selected the School Vacation Package) and Summer Camp are not included and require pre-registration and extra fees. Extra Days will be available as needed based on availability.

_____ I understand that tuition payments are due on or before the 1st of the upcoming month my child is enrolled in The Children of Tomorrow Inc. for care. The tuition for the school age program is billed in 10 equal monthly tuition payments from September 1st through June 1st.

_____ I understand that all services not paid for on or before the due date(s) will be assessed a \$10 a day late fee. Childcare services may be suspended until services are paid in full, including late fees.

_____ I understand the Tuition, Payments and Fees policy as listed in section VII of the Parent Handbook.

_____ I understand that I will be charged an additional fee of \$15/15 minute interval for attendance earlier than or later than the center hours and repeated offenses may result in termination of care.

_____ I understand the Illness and Exclusion policy (see parent handbook).

_____ I understand that I will be responsible for finding back-up care for my child when The Children of Tomorrow Inc. is closed and unable to provide care including for emergency/weather closures or delays. This includes when due to illness/exclusion, my child is excluded from care.

_____ I understand the policy for people other than parent/guardian picking up my child and understand that even if I have added names for authorized pick up, I will still need to notify staff in advance of any alternate pick up.

_____ I understand the withdrawal policy as listed in the Parent Handbook, which states that the school age before and after school enrollment is a commitment to remain enrolled for your current schedule for the full school year. Withdrawal or reduction of days mid-year will not be permitted.
