### **Optional School Vacation Package**

**NEW**-you can choose to add on the school vacation package and your child will be automatically enrolled in the school vacation weeks in December, February and April for just \$65/month.

- ★ NEW-No School Days now included with no extra fees for attendance on early release days, snow days & delays (if we are open), public school professional development days and many school holidays. If school is closed on your regularly scheduled day your child is automatically eligible for care with us with no extra fees! School Vacation weeks and Summer Camp are NOT included in the regular monthly rates but can be added if needed
- ★ You can sign up for any combination of days. However, schedules must be consistent from week-to-week except when signing up for extra days and the school vacation package.
- ★ Enrollment in the School Age Program follows the Charlton academic school calendar beginning when school starts in August and through the last day of school in mid/late June.
- ★ The School Age Program *monthly* rates are billed in 10 equal, monthly payments due on the first of every month from September 1st June 1st.
- ★ The Children of Tomorrow Inc. is privately owned and operated. We are not a franchise and have been proudly providing top-notch childcare services to our community for 20 years! Our staff are educated and experienced teachers who strive to make a difference in the lives of their students.
- ★ School Age Summer Camp is a separate, optional program that is also available during summer break.

  Those of you who are enrolled in our School Age Program will get the opportunity to sign up for Summer Camp before we open enrollment to the public. Space is limited and this program fills up fast.
